#### **Thoughts on Step 11**

A Sixth Sense of Direction, Sometimes Quickly, Sometimes Slowly...

In the beginning through meetings, fellowship & sponsorship I was able to learn & understand the importance of the phrase, "God as we understand him" to believe in something greater than ourselves. In turn, I was no longer the actor up on the stage without a script. This I learned from steps 1 through 3, a good sponsor who encouraged me to trudge onward past these steps into the heart of the program (Steps 4 through 9) & not get hung up on this statement. I struggled none the less, because up to that point in my life, I could only tell you that God had done nothing for me in my life other than not answer my prayers. My sponsor & other fellows through meetings encouraged me simply to start with stating that the meetings themselves, my fellows in the meetings, could be the higher power of my understanding to start. At that time in my life, what I consider today as ground zero, being physically, spiritually & mentally bankrupt, I thought I could tolerate. One thing I knew very strongly, that if I took that next drink, it meant death.

From that point forward, although I can't say exactly when other than at some point early in the program, I began to move forward with this concept. Through numerous meetings, meeting with my sponsor on a weekly basis & fellowship, I began to practice prayer & meditation through simply reading 24 Hours A Day, Daily Reflections & As Bill Sees It. No more, no less, every morning I took 5 to 10 minutes & read these books. Despite this action, for quite some time I chose to not pray. For me, it was a starting a point, a building block. As time went on, I became willing to get on my hands & knees, meditate & find calmness in the nature that exists outside my window coupled with the 5<sup>th</sup> step & the Serenity prayer after my morning readings.

As my roller coaster ride continued in early sobriety, my self will came back at times & I would find myself stepping back from this daily morning practice. Each time this occurred, sometimes quickly, sometimes slowly, I would find myself wrestles, irritable & discontent until I was completely exhausted mentally. Each time this occurred, I left myself with no choice but to go back to my morning readings, prayer & mediation. I'm positive today, that if I had not taken this action I would have gone back out. I found myself more willing than before to get on my hands & knees, acquiring a sense of calmness from these actions each morning before I began my 24 hours. I attribute much of my willingness to go back to daily morning prayer & mediation to meeting with my sponsor on a regular basis, multiple meeting attendance every week & fellowship. It's through that courage & strength I began to see in my daily life that I was beginning to improve my conscious contact with a God of My Understanding.

Thoughts on Step 11 continued...

Today, for me, I refer to my higher power as the spirit that flows inside each of us. If we are willing to listen, be patient & wait for it, the spirit will present itself. Through continued practice, that spirit, a higher power of my understanding coupled with Steps 10 & 12, that I have come to find that  $6^{th}$  Sense of Direction at times. Not always, but enough that I know what it takes today to find it.

Today in times of indecision, I ask for direction from my higher power. Today, I don't struggle as much with times of indecision to the extent I did before sobriety. Through working with my sponsor & my fellows in the program I ve learned to wait for it. In time, that 6<sup>th</sup> Sense of Direction comes to me, sometimes it comes through conversation with another fellow or from a meeting. Sometimes it plainly comes from the spirit that I believe today exists in nature, such as a White Pine blowing in the wind. If I pay attention to those moments of calmness, if it calms my spirits enough, spawns enough positive thought & reflection on my time of indecision, the answer to my indecision will come to me.

"Sometimes quickly, sometimes slowly". Today, I can honestly say I have experienced a Spiritual Awakening, a personality change sufficient enough to recover from alcoholism. "Patience" is the key word, for this will not happen overnight & it is to be practiced for a lifetime!

#### 11th Concept

#### Concept XI: "While the Trustees hold final responsibility for A.A.'s world service administration, they should always have the assistance of the best possible standing committees, corporate service directors, executives, staffs, and consultants. Therefore the composition of these underlying committees and service boards, the personal qualifications of their members, the manner of their induction into service, the systems of their rotation, the way in which they are related to each other, the special rights and duties of our executives, staffs, and consultants, together with a proper basis for the financial compensation of these special workers, will always be matters for serious care and concern.'

This concept deals with the special workers and committees of the General Service Board that work to support and advise the Trustees, as well as A.A. World Services and The A.A. Grapevine. The standing committees of the General Service Board are Nominating, Finance, Budgetary, Public Information, Literature, and General Policy. Each committee deals with issues specific to name of the committee. They advise the Trustees on matters related to the operation of A.A.. They sort through many different issues to determine which should be addressed by the Trustees and which can be dealt with at a committee level. This screening of issues helps the Trustees to have the time to deal with the more difficult issues.

The Nominating committee thoroughly reviews all people who are up for any of the A.A. jobs, committees, administrative positions, and Trustees positions that are coming open. They then make recommendations for the best person to fill the position. The other committees advise on subjects related to their specialties.

All workers, except Grapevine, are on a rotation of one year on the job, then they are moved. Each person is expected to learn and perform the jobs the are moved to. Paid compensation is equal for all of the workers. The Grapevine is set up differently because it is a current publication and is changing with each issue. The creativity needed to make this happen is a special gift that cannot be easily replaced.

The big part of all of these people working together is the spiritual aspect of everyone working together in harmony. There is a drive to do the work of A.A. by all paid or volunteer positions. There is no organizational structure that can fully guarantee the A.A. Headquarters against the depredations of clashing personalities. Only a sustained willingness to practice spiritual principles in all our affairs can accomplish this. In this spirit we shall never need to fear for our future harmony.

#### District 5 Monthly Meeting Notes- Nov. 10,2010

Meeting opened by the DCM with the Responsibility Statement.

**Introductions:** 17 present

**Secretary's Report:** There was a question about Treasurer's report last month and she was not able to attend so the report was accepted and seconded as is until next month.

**Treasurers Report:** Checking brought forward: \$2427.42, 6 groups contributed \$205.00, check dispersements \$427.25, ending balance \$2205.17. Savings \$452.34,.10 interest balance=\$452.44. Report was accepted upon review next month.

**DCM Report:** Paul reported about the Fall Assembly. The turnout was good with only 7 of the 24 Districts missing. There will be a Eastern Regional Conference held in Green Bay sometime in July, more on that will follow. There is available the "New AA Comes of Age" in soft cover which will make it institutionally friendly. There will be another AA 2011 survey and this will be random. Paul asked to be reimbursed for \$26.00 for gas and meal at Assembly. John made a motion to accept Paul's request with Nickalas seconding the motion, the motion passed.

New Business: Denny T. asked why the District could not buy the printer that is brought by a GSR to our District meeting every month to help make copies. #### **Quarterly Reports:**

A GSR from Pierce County expressed an interest to get Big Books, Daily Reflections and Twelve by Twelves into their jails. Jackie wasn't sure what the procedure was and is going to check into it but she took the GSR's name and # and will contact him. Members were concerned that we still have 20 Big Books and felt we should give to any jails in our District. Jackie is going to follow up on it. She asked to be reinbursed

**\$30.00** for rent at Club 12 and **\$352.76** for Big Books, P.O.Box renewal and copies. Motion was made and accepted.

**PI:** John continues to work on his goals of having Big Books in the libraries and meeting lists in hotel/motels. He has covered the meeting list in River Falls, Prescott, and Ellsworth.

#### **Thoughts on Tradition 11**

**Tradition Eleven**: "Our public relations policy is based on attraction rather than promotion; we need always maintain personal anonymity at the level of press, radio and films."

My experience with this tradition happened many years ago. The local news station was doing a report on teens and alcoholism, and wanted an interview with a teen in Alcoholics Anonymous. The reporter and his entire camera crew showed up to my meeting. Luckily, an old-timer was there to direct the crew into a back room of the church and explain the traditions to the reporter, his crew, as well as myself (the newcomer). As a result, the reporter had to change his plan at the last minute, but he was more than willing to show only my hands on my lap during the interview. Rather than giving my name, he referred to me only as "an anonymous teen in AA."

I had never been on TV before, and my ego really wanted to make this experience all about me. Why shouldn't I take a chance at getting one step closer to Hollywood? It must be God's will for me! Maybe AA was okay, if it meant a chance in the spotlight....

Had it been up to me, I would have put my childish self-centered desires ahead of Alcoholics Anonymous as a whole. I could have seriously jeopardized other people's chances of sobriety. Who wants to go to AA if they have been given the impression that the program is full of self-obsessed, preachy teens? I was irritated that the old-timer impeded on my interview, at the time. Now that I have had a spiritual awakening as a direct result of taking some simple steps, which are outlined in the Big Book, I am grateful for the guidance and direction that was so desperately needed. Thank you old-timers, for saving us from ourselves!

#### In The Beginning

This section exists with hopes to connect to newcomers regardless of the Step,
Tradition, or Month we are in.

"Hi, I'm Nicholas, I'm an alcoholic" words that I had muttered time and time again with pride. I wore that badge like a freshly crowned eagle scout beaming with pride in front of his parents. I sat in that church that day with a sense of relief, remorse, and confusion. "Had it really came to this?" "How did I get here?" "Seriously, the rest of my life will be spent in these rooms?"

Alcohol was no longer my friend, the anticipation of the first drink was no longer an event, I had to drink continuously or I became very ill. The euphoria 3 or 4 drinks in of *knowing* it was going to be a fun night was gone, for I was alone, in my room dozing in and out of consciousness. The laughter and bellowing hollers of my *friends* had all been quieted, for I now drank alone, it was just easier. I was dead inside. I was now but a human shell with no life inside, twinkle in my eye, or desire to move on.

If you are questioning if you belong or not, normal drinkers don't go to AA and normal drinkers aren't reading this article right now, but that is for you to decide. My tendency was to listen to how we were different. I was certain I didn't belong because my story was different. There were no young gay men in AA. The solution might have worked for vou, but my case was different. All of us suffered from this phenomenon that we were special, unique, and different. I recently watched the Karate Kid. The new version with Jackie Chan and Jayden Smith, it reminded me of stories from Alcoholics Anonymous on a few levels. Most of us remember the original version with Ralph Machio and Pat Morita. The point is the stories are identical. Only the nuances are different; karate kid's age, location, ethnicity, etc. That is AA. Our stories are identical; the difference lies only in the nuances. My sponsor didn't look like Pat Morita either! I've heard some have similar sponsoring techniques "Wax On, Wax Off" or "Hang the jacket, take down the jacket" Just kidding!

I continued to go to meetings and stayed sober between meetings and things immediately improved. I wasn't getting sick. I slept through the night, and generally felt better in the morning. As I began working the steps with a sponsor *more was revealed*. I began to have clarity in other parts of my life. Situations that use to baffle me, I now intuitively new how to handle. When I didn't, I called my sponsor.

The beautiful component of this program is in its unity. You are not alone. The vast diversity of its membership grants us friendships that we never imagined, support we never thought possible, and *hope*, something we never had.

If you are here, you probably belong here. Keep coming back. Get the <u>Big Book of Alcoholics Anonymous</u>. Get a sponsor.
