Greetings fellow AA's,

I hope this edition of our monthly newsletter fines you well. It is my hope that many of you might be reading this newsletter or receiving it directly for the first time. We launched an idea in February to increase the readership by asking AA members to sign up to receive this publication via email free of charge. Our district thought this was a great tool to keep all members of our district informed of the goings-on in Alcoholics Anonymous in Western Wisconsin.

I would like to take a moment to talk about how I came to sponsor 3 individuals. One man found himself in treatment after his 4th dui, another in a correctional facility after issues with the law, and the 3rd at the University of Wisconsin – Eau Claire counseling services after having academic struggles. All 3 of these potential alcoholics were directed to Alcoholics Anonymous through those respective institutions. How is that you ask? It is an active committee structure in our district committed to carrying the message of Alcoholics Anonymous to places that come into contact with potential members. Our treatment committee carries the message of recovery into treatment centers, corrections committee to jails, and cooperation with professional community committee to those who have professional jobs that may encounter potential alcoholics asking for help. These 3 committees are active, vibrant, and expanding in district 5.

The meeting lists found on the tables of your AA meeting are maintained through our district webmaster as well as the up-to-date web page itself.

Our Public Information Committee has reached 100's of churches in our district and is establishing a contact program with high school guidance counselors.

Our committees have carried the message of AA to literally thousands of potential alcoholics and members of Alcoholics Anonymous over the past few years and they continue to think of ways to reach the still suffering alcoholic.

I do not write about these items gratuitously, but rather with excitement and passion. I attend a monthly conference call with the other DCM's from our area and am proud to say our district is as active as a district there is in our area. We are providing opportunities for our AA members to fulfill all 3 legacies of AA by providing ample service opportunities. This type of activities rarely get mentioned in our weekly meetings or from the podium and my wish is by reading this you may begin to ask how to get involved. I truly believe service is the secret and it is how we carry the message to the still suffering alcoholic.

I extend a deep thank you to the AA members of District 05 and the AA Groups of District 05 that have in the past and continue to support our district efforts. These committees need you and your groups help, this isn't work that can be done by a few or for free. It takes time and resources. Please feel free to contact me if you would like to learn more about getting started in service. The Fall 2014 Area Conference Steering Committee met at Alano Club 12 in Eau Claire on March 2, 2014. Fourteen were present on another cold winter afternoon. Chairman Gary S. apologized for being late and then opened the meeting. (I don't know if this qualifies as a good example of practicing step 10.)

Program committee: Mike McG. Could not be at the meeting but he passed on the information that the subcommittee now has 6 members and that they are working on the following:

- Working on scripts for all meetings and panels

Treasurer: Bryon B sent out the current budget to all committee members and requested that it is just a guideline. That each committee should submit a budget reflecting their anticipated needs.
