## Motion submitted by Jason L. on behalf of the Back to Basics Big Book Study of E.C.:

I propose a motion to vote at the District 05 Monthly Meeting on January 14, 2015, on the creation of an Ad Hoc committee; composed of up to 6 persons including current DCM, previous DCM, elder statesman (not gender specific) with significant Area level experience, and up to 3 GSR's; charged with creating recommendations for District Guidelines with the following criteria:

- Update job descriptions
- Define who has a voice, a vote, and/or the ability to make motions at regular Monthly District meetings, and at Committee meetings.
- Procedures for reimbursements for both an officer and a committee chair's budget, as well as non-budgeted reimbursements by anyone.
- Procedures that define how to handle Elections for officer positions, also both normal
  elections of committee positions and special elections in the event of absence of a chair
  (ie: Corrections, CPC, PI, Special Accommodations, Treatment), recommendation-based
  positions (such as Webmaster and Newsletter Editor) as well as defined election cycles.
  This will include how to handle nominations and voting process, requirements to vote,
  also special elections for position vacancies.
- Consideration of periodic review (such as every 2 or 4 years) possibly comprised of the same or similar roles.

# Documentation to assist with this process should include at minimum but not limited to, the following:

- AA Service Manual
- 12x12
- Area 74 Guidelines
- Guidelines of any other District that can be located and deemed useful by the committee
- Recommendation and Voting process for Webmaster and Newsletter Editor positions approved by District 05 at the November 12, 2014 Monthly Meeting
- Any pertinent documentation that may be available from archived DCM files which would include job descriptions.

## **Timeframes:**

- Begin meeting in February 2015
- Final recommendation to be presented no later than the July 8, 2015 District 05 Monthly Meeting.
  - Note: August through October may be needed to consider suggested revisions/clarifications.

#### **Intent of the Motion:**

This motion was created in hopes of clarifying procedural matters that will minimize the need for discussion of how to conduct some of our district's business; specifically elections, reimbursements, and who has a voice and/or a vote. Further, to allow our leadership and our body to make better use of meeting time, especially for those who come to serve in future election cycles. Last, in creating the above mentioned recommendations, the committee should possess a spirit of flexibility and a spirit of cooperation, not setting too tight of restrictions so that District 05 would <u>not</u> in any way lose the ability to be flexible on most procedural matters in normal business meeting, that would allow good ideas to be heard and considered.

## **Brief History:**

Multiple members of our district were surprised to discover that no District Guidelines exist, after discussion at the November 2014 District 05 Monthly meeting. After participating in conversations initiated by a few members, I reached out to more than 10 members of my home group as well as 6 other GSR's, all of which expressed support of the idea of forming an Ad Hoc committee to make recommendations for District Guidelines, consisting of the membership identified above.
