### DCM Report: Bryon B.

The Treatment Committee will be hosting a workshop on October 22nd from 4pm 6pm at Club 12 in Eau Claire. The workshop will include a presentation of what it should look like as a speaker going into a treatment facility. Dave S and Jennifer H will be the presenters and there will be people in the audience asking questions to give a realistic idea of what it looks like in these facilities. We ask that Intergroup, Archives and all of you are able and willing to join us. Pizza and soda will be served following the presentation.
- We will no longer be sending speakers into the Eau Claire Metro and the New Journey program is up in the air at this time due to variation in their treatment offerings.
- I am requesting \$40.00 to purchase four Big Books to take into Sacred Heart Hospital and Mayo Hospital Behavioral Health units. From what I have been made aware, meetings in the jails in our district and in the Chippewa and Stanley prisons are continuing without any major interruptions.
