## Public Information (PI): Paul M.

- The PI Committee met on 1/20 at the River Falls Alano Club. We had a brief welcoming of Paul M. as the incoming chair and discussed objectives for the 2-year term.
- Discussed the added responsibility of managing the website and what this would entail from the committee. It was noted that it should not be incumbent on the committee to create a heavily regulated environment for the Webmaster to operate in. However, drafting some guidelines or best practices would be a good idea. We don't want to inhibit the Webmasters ability to make necessary technical updates to the website or require approvals for posting information. However, we felt that "anonymity is the spiritual foundation of our website."
- We then discussed other projects the committee is working on and soon discovered that the level of detail required for each project would greatly exceed our 1-hour time slot. Since we meet every other month, progress would be very slow. Therefore we decided to have the "projects" form into sub-committees and

hold their own meetings as they see fit. This would give them the time to discuss the details of the project and bring updates to the committee meeting. The committee can give feedback and communicate progress, problems or concerns to the District.

## **Cooperation with the Professional Community (CPC): Robert S.**

- January Meeting was held as scheduled. February meeting was canceled due to snowstorm.
- UW Stout Presentation A CPC presentation was given 2/9/2016 4:45PM to 6:15PM. Details will be shared at next month's CPC meeting.
- UW Stout Counseling Services Another presentation opportunity at UW Stout. This will be either February 17th or 24th.
- Rural Institute for Alcohol and Drug Abuse conference in Menomonie in June on the UW Stout campus. CPC will be at the AA booth.
- Arbor Outpatient Staff The outpatient side of Arbor may be interested in a CPC presentation.
- Veterans An AA visitor attended CPC meeting in January. Discussions on what CPC might do with veteran organizations. Information was given on how the VA works and what resource are currently available.
- Law Enforcement Discussions on how CPC might work with law enforcement.
- Homeless Shelters, Community Table etc. Discussions on how CPC might work with these organizations.
- CPC requests a check payable to Alano Club 12 in the amount of \$20 for 2 months of rent at \$10 per month.
- Requested reimbursement for \$20 made out to Club 12 Approved

# <u>Treatment (TFC): Sara D.</u>

- We are currently in the process of updating our temporary contact list and volunteer speaker list.
- Our secretary is creating a Google spreadsheet for all coordinators to use. The purpose of this spreadsheet is to be better organized in regards to not sending the same speakers into multiple facilities.
- There is an open position for Affinity House coordinator. In the meantime Mary Beth is filling in until someone is elected.
- Arbor Place is interested in sending a speaker in for their outpatient program.

#### Corrections: Ken P.

- The committee requests rent to be paid to Club 12 for \$30.
- At the March Corrections mtg. we will be stuffing packets for volunteers entering the jails, with viable information for inmates such as: Meeting Lists, Pre-release Forms, Informational pamphlets, etc.
- Volunteer Applications are to be sent to the chair of the committee for review. If the volunteer applicant does not qualify per the jail rules, the application will not be forwarded and the applicant notified. If there are no known issues, the chair will forward the application to the jail programs coordinator and notify the applicant.
- We are still in need of male and female volunteers to go into the jails we serve. Requirements are: Have worked through the steps with a sponsor, AND have been off probation, parole, etc. for at least two years.
- A reminder that anyone interested in being of service to incarcerated alcoholics is welcome to attend meetings of the District 05 Corrections Committee. Meetings are held at 7:45 pm the first Wednesday of each month in the small building of Club 12 in Eau Claire.
